## **Boarding & Daycare Agreement**

Please read the following carefully. If you do not understand the agreement below please consult a Elite Pet Resort Staff member for clarification.

1.	I understand that Elite Pet Resort has relied upon my representation that my dog is in good health and has not injured or shown aggression or threatening behavior to any person or dog in admitting my dog for services.  Initials
2.	I further understand that their owners, staff, partners and volunteers, will not be liable, financially or otherwise, for injuries to my dog, me or any property of mine while my dog is participating in services provided by Elite Pet Resort. I hereby release Elite Pet Resort of any liability of any kind arising from my dog's participation in any and all services provided.

3.	I further understand and agree that any problems with my dog, behavioral, medical, or otherwise that arise while my pet is in the care of Elite Pet Resort will be treated as deemed best by the staff in their sole discretion. I assume full financial responsibility and all liability for any and all expenses involved in regards to the behavior and health of my dog.

4.	I further understand that there are risks and benefits associated with group socialization of dogs. I agree that the benefits outweigh the risks and that I accept the risk. I desire a socialized environment for my dog while attending daycare and while in their care. I understand that while the socialization and play is closely and carefully monitored by staff members to prevent injury, it is still possible that during the course of normal play my dog may receive minor nicks and scratches from roughhousing with other dogs. Any injuries to my dog will be pointed out by staff upon pick-up.
