1. I understand that Elite Pet Resort has relied upon my representation that my dog is in good health and has not injured or shown aggression or threatening behavior to any person or dog in admitting my dog for services.

I further understand that their owners, staff, partners and volunteers, will not be liable, financially or otherwise, for injuries to my dog, me or any property of mine while my dog is participating in services provided by Elite Pet Resort. I hereby release Elite Pet Resort of any liability of any kind arising from my dog's participation in any and all services provided.

I further understand and agree that any problems with my dog, behavioral, medical, or otherwise that arise while my pet is in the care of Elite Pet Resort will be treated as deemed best by the staff in their sole discretion. I assume full financial responsibility and all liability for any and all expenses involved in regards to the behavior and health of my dog.
